Clerk Report:

Last month the Town took in \$741; \$38 in Dog Licenses, \$70 in Transfer Station Permits, \$116 in Building Permits and \$517 in Sporting Licenses. It was disbursed; \$488.45 to the DEC and \$252.15 to the Supervisor.

Code Enforcement:

John Furlong reported 5 inspections for August and 4 for September, 2 new permits, 3 Certificates of Compliance, and completed 24 hours of in-service training. He has now completed the required training for 2024.

Dog Control:

Pat Ashbey reported one dog to be quarantined by owner for 10 days per Dept. of Health.

RESOLUTION #50-24

Amend Permission to Expend Highway funds

Councilman Becker offered the following Resolution and asked for its' approval:

Resolved; the Bleeker Town Board does hereby amend the Permission to Expend Highway Funds, Resolution #35-24, from \$142,000 to \$162,000, and amend the Budget accordingly.
