Public Comment:

There was an expression of concern by some residents of the Town concerning the re-appointment of David Galarneau as Assessor. His term expires in September, and the Public commenters asked the Board to seriously consider not appointing him, citing a lack of transparency in assessing their properties and a general lack of respect for them personally. The Board will take their concerns seriously when discussing how to proceed, but since one Board member was not present, the decision will not be addressed at this meeting.

Councilman Becker made a motion to adopt the minutes from the last meeting. It was seconded by Councilman Smith and approved; In Favor: 4 Opposed: 0

Clerk Report:

The Town took in \$170 in February, all in Transfer Station Permits. It was given to the Supervisor.

Code Enforcement:

John Furlong performed 1 inspection, and issued 3 Certificates of Compliance.

Hwy, Bldg, Grounds:

Jeff Brooks said that he needs to expand the sand pit, entailing clear cutting more usable area. He asked for permission to have the acreage logged, and the proceeds put into the Equipment reserve.

**RESOLUTION #21-25**  
**Authorization to Log the Sand Pit**

Councilman Becker offered the following Resolution and asked for kits' approval:

**Resolved:** the Bleecker town Board does hereby authorize Jeff Brooks, Highway Superintendent, to contract for the logging of the Town's sand pit, and the proceeds to be deposited in the Highway Equipment Reserve.

Supervisor Howard presented the new CDPHP Health Insurance plans. He recommended keeping the current plan, citing the fact that, although the premium increases, the network stays the same. The premium will increase by 19% from last year.
